Steering committee meeting of 28 March 2019 in Pretoria

The first steering committee meeting of 2019 took place in Pretoria and was hosted by the City of Tshwane. A guest presentation was made by Dr Heinrich Bohlmann from University of Pretoria. The title of the presentation was *Big Bills Left on the Sidewalk: Making Proper Use of Models for Macroeconomic Planning*.
